WHEREAS it appears from the several Court Order passed by Hon'ble High Court, Calcutta that direction has been made upon the respondent authorities to refund overdrawal amount caused due to wrong fixation of the pay during the course of employment of the employee of Non-Government Sponsored / Aided Educational Institutions.

AND

WHEARAS the direction has also been made upon the respondent authorities to disburse the post-refiral benefit to the petitioner on the basis of last drawn pay which is not admissible pay / actual pay of the petitioner in terms of existing Government Rules / Orders.

AND

WHEREAS it is to be noted here that allowing such inadmissible pay for calculation of post-retiral benefit of any employee of Non-Government Sponsored / Aided Educational Institutions will lead to heavy drainage of public money from the Government exchequer.

AND

THEREFORE, in such circumstances the Governor has been pleased to decide that the fixation of pay of the employee during the course of employment in al stage (i.e. joining, promotion, ROPA, CAS etc.) has to be vetted by the concerned Joint Director / Deputy Director / Assistant Director of Accounts, School Education Department, Government of West Bengal posted in the concerned office of the District Inspector of Schools prior to issuance of any approval from the concerned District Inspector of Schools with immediate effect.
