MEMORANDUM

Sub: Revision of pension/family pension of pre 01.01.2006 pensioners/family pensioners-implementation of Government decision on the recommendation of the Fifth Pay Commission.

The undersigned is directed to state that in pursuance of Government's decision on the recommendation of the Fifth Pay Commission, orders regarding revision of pension/family pension of pre 01.01.2006 pensioners/family pensioners of Government Polytechnics/Government Sponsored Polytechnics had been issued vide this Department's Memo No.995-TET (Poly), 996-TET (Poly), 999-TET (Poly), 1000-TET (Poly), all dated 18.12.2012, as an extension of benefit of Finance Department's Memo No.200-F(Pen) dated 25.02.2009 and School Education Department's Memo No.73SE(B)/1M-4/2009 dated 19.05.2009.

Now, after careful consideration of the matter, the Governor has been pleased to adopt the provisions contained in Finance Department as well as School Education Department Memos ibid, as mentioned below:

- i) Para 4.2 of all the above Memorandum dt.18.12.2012 ibid should be read as in case of pensioners who is/are in receipt of two pensions; one Service Pension and the other Family Pension, the service pension shall be stepped upto Rs.3300/- if it falls below Rs.3300/- after consolidation and the other pension will simply be consolidated and will not be stepped up, if it falls below Rs.3300/-.
- ii) In case of pensioners who are in receipt of more than one family pension the overall ceiling of Rs.3300/- will apply to the total of all pensions taken together as embodied in Para 4.2 of both the Memo No. 200-F(Pen) dated 25.02.2009 and 73SE(B) dated 19.05.2009.
- iii) The amount of additional pension/family pension as detailed at Para 4.4 of Memo Nos. 999-TET(Poly) and 1000-TET(Poly) & Para 4.5 of MemoNos.995-TET (Poly) and 996-TET(Poly) all dt.18.12.2012 shall be shown distinctly in the P.P.O. as per provision laid down in F.D.'s Memo No.191(350)-F (Pen) dt.16.04.2012 read with Memo Nos.635-F(Pen) dt.14.07.2010 and 1025-F(Pen) dt.24.12.2010.
- iv) With a view to simplifying the procedure for fixation of revised pension to the pre 01.01.2006 pensioners/family pensioners in terms of para 4.4 of this Department's Memo No. 999-TET (Poly), 1000-TET (Poly) both dated 18.12.2012 the provisions contained in Finance Department's Memo No. 460-F(Pen) dated 20.05.2009 read with Memo No. 1046-F (Pen) dated 19.11.2009 are to be followed.

The undersigned is further directed to state that for revision of pension /family pension in respect of pre 01.01.2006 pensioners/family pensioners of Government Polytechnics and Government Sponsored Polytechnics, the cases are required to be sent to the office of The Principal Accountant General (A&E), West Bengal and Office of the DPPG, West Bengal respectively for further authorisation, as the case may be, in terms of this order.

This order is issued with the concurrence of the Finance Department, Pension Branch, vide their U.O. No. 69-F(Pen) dated 17-02-2017.
