MEMORANDUM

Sub:

Family Pension for life to children suffering from disorder/ disability of mind or are physically drippled/disabled of the teaching and non-teaching staff of the Non-Govt. aided educational institutions.

For sometime past the question of extending the benefit of family pension for life payable to children suffering from any disorder/disability of mind or are physically crippled/disabled of a retired teaching or non-teaching staff of the non-government aded institutions have been under active consideration of the Government.

After careful consideration of the matter in all aspects the Governor has been pleased to decide that the son or daughter of a retired teaching and a non-teaching staff of the non-Govt, aided educational institutions who is suffering from any dis-order or disability of mind or is physically crippled or disabled so as to render his or her to earn a living even after attaining the age of 25 years in the case of the son and 25 years in the case of the daugher. The family pension shall be payable to such son or daughter for life subject to the following conditions:-

- If such son or daughter is one among two, or more of the non-Govt, aided educational institution employee, the family pension shall initially payable to the minor children In the case of minor son until he attains the age of 25 years and in the case of unmarried daughter untill she attains the age of 25 years or marriage which over is earlier, as the case may be, and thereafter the family pension shall be resumed in favour of the son or daugher suffereing from disorder or disability of mind or who is physically crippled or disabled and shall be payable to him/her for life:
- ii) If there are more than one such son or daughter suffereing from disorder or disability of mind or who are physically crippled or disabled, the family pension shall be payable in the order of their birth and the younger will get the family pension only after the eldernest above him/her ceases to be eligible. When the Family Pension is payable to twin children, tit shall be paid to such twin children in equal shares, provided when one such child ceases to be eligible, his her share shall revert to the other and when both of them cease to be elegible, the family pension shall be payable to the most eligible single

- child twin children. This shall apply to children of teachers/employees dying retiring on or after the date of issue of this order.
- iv) before allowing the family pension for life to any such son or daughter, the sanctioned authority shall satisfy that the handicap is of such a nature as to prevent him or her from earning his or her livelihood and the same shall be evedenced by a certificate obtained from a medical officer not below the rank of a civil Surgion actting out, as far as possible, the aspect Mental or Physically condition of the child.
- v) The person receiving the family pension as guardian of such son or daughter shall produce every three years a certificate from a medical officer not below the rank of civil surgeon to the effect that he or she continues to suffer from disorder or disability of mind or continues to be physically crippled or disabled. Provided that such children are not in receipt of any kind of pension whatsever from any Government/Undertaking etc. on account of his/her such disability.
