Corrigendum

In terms of School Education Deptt.'s memo No. 324-SE(B)/1M-43/2003 dt. 5/9/05, Family Pension was admissible to the 'dependent' son and daughter of the deceased teacher and non-teaching employees of West Bengal Non Govt. Recognised Institution upto 25 Years subject to other terms and conditions.

Now the Governor is pleased to omit the word 'dependent' in the 3rd line of para 3 of the said memo as it is contrary to the spirit of provisions of para 26, 28 of DCRB Scheme 81.

This order issues with the concurrence of Finance Deptt. Pension Branch vide their U.O. No. 837 dt. 1/11/07.

Sub : Clarifications of Memo No. 324 -SE (B) 1M- 43/
2003 dated 05.09.2005.

The undersigned is directed to refer to his letter No. 647-DPPG dated 01.09.06 and to furnish below the clarifications of this Department's Memo No. 324 -SE (B) 1M-43/03 dated 05.09.05

i) Only the sons who have not crossed the age of 18 years on 05.09.05 and only the daughters who have not crossed the age of 21 years on 05.09.05 will continue to receive family pension (after the death of spouse) upto the age of 25 years even though the pension/family pension (spouse) ceases in the meantime.

But this will not apply in those cases where the pension/family pension (to spouse) ceases before 05.09.05.

A prayer to this affect supported with proof of age of son/daughter along with a copy of P.P.O. be made to DPPG West Bengal who in turn, issue fresh / subsidiary P.P.O. order showing the name of son/daughter and the period of entitlement.

This will be further applicate to adopt/step son/daughter also or to son/daughter born through marriage after retirement.

ii) The word dependent in the 3rd line of para 3 of Memo No 324 -SE (B) dated 05.09.05 is omitted'. This has the approval of Finance Department (pension) U.O. No. 837 dated 01 X 1.07
