MEMORANDUM

Sub : Revision of Pension/Family Pension of pre 1.1.96 pensioners/family pensioners who enjoyed pay under Revision of Pay and Allowances Rules, 1990 issued under Memo No. 33-Edn.(B) dated 7.3.90 of Education Department, Budget Branch, Government of West Bengal.

AND

Further revision of Pension/Family Pension structure of pre-1.1.86 pensioners/family pensioners who retired/died while in service on/after 1.4.81 and before 1.1.86 and Pension/Family Pension rationalised under Memo No. 38-SE(B) dated 6.3.96— Implementation of the Government decision on the recommendation of the Fourth Pay Commission.

The undersigned is directed to state that in pursuance of the State Government's decision on the revision of pensionary benefits as published in this Department's Memo No. 123-SE(B) dated 29.6.99, sanction of the Governor of West Bengal is hereby accorded to the regulation/revision of pension/family pension with effect from 1.4.97 of all pre-1.1.96 pensioners/family pensioners who enjoyed pay under ROPA'90 in the manner indicated in the succeeding paragraphs. Such benefit is also extended to the pensioners/family pensioners who retired/died while in service between the period from 1.4.81 and 31.12.85 (both days inclusive) after enjoying pay scale of ROPA '81.

2.1 These order apply to all pensioners/family pensioners who were drawing pension/family pension on 1.1.86 on the basis of ROPA '81 pay scale and on 1.1.96 on the basis of ROPA '90 pay scale respectively under the West Bengal Recognised Non-Government Educational Institution Employees (Death-cum-Retirement Benefit) Scheme, 1981 read with Memo No. 157-Edn(B) dated 13.6.90.

2.2 These orders do not apply to a pensioner whose pension etc. is governed by separate rules/orders/memos.

3.1 In these orders, the following terms are used in the sense explained herein below:
(a) "Existing Pensioner" or "Existing Family Pensioner" means a pensioner who was drawing/entitled to pension/family pension, disability pension, extra-ordinary family pension on 31.12.95, in terms of Memo No. 157-Edn.(B) dated 13.6.90, subject to the conditions that they enjoyed scale of pay fixed under ROPA Rules, '90 and for those who retired/died while in service prior to 1.1.86 but not before 1.4.81, and whose pension has been consolidated as per Memo No. 38-SE(B) dated 6.3.96. For the purpose of updating family pension it also covers members of family of employees who retired prior to 1.1.96 enjoying scale of pay under ROPA Rules, '90 and in whose cases family pension has not commenced as the pensioner is/was alive on 31.12.95 and the benefit as such is also extended to the pre-1.1.86 family pensioners in whose cases family pension has not commenced as the pensioner is/was alive on 31.12.85.

(b) "Existing Pension" means the basic pension inclusive commuted portion, if any, sanctioned as per Memo No. 157-Edn.(B) dated 13.6.90 due on 31.12.95 or the consolidated pension as per Memo No. 38-SE(B) dated 6.3.96, as the case may be due on 31.12.95. It covers all classes of pension as mentioned in West Bengal Recognised Non-Govt. Educational Institution Employees (Death-cum-Retirement Benefit) Scheme, 1981.

(c) "Existing Family Pension" means the basic Family Pension/Extra ordinary Family Pension due on 31.12.95 under the West Bengal Recognised Non-Government Educational Institution Employees (Death-cum-Retirement Benefit) Scheme, 1981, in terms of Memo No. 157-Edn.(B) dated 13.6.90, or the consolidated family pension as per Memo. No. 38-SE(B) dated 6.3.96.

(d) "Existing relief" means the relief on pension/family pension due to pensioners/family pensioners at the rates contained in Finance Department Memo No. 1120-F(Pen.) dated 20.8.96 i.e. @ 148%, 111% and 96% of Basic Pension as admissible.

4.1 The pension/family pension of existing pre-1996 pensioners/family pensioners and pre-1.1.86 pensioners/family pensioners as mentioned at para 3.1(a) above will be consolidated w.e.f. 1.4.97 by adding together :-

- (i) Existing Pension/Family Pension
- (ii) Existing relief on Pension/Family Pension.
- (iii) First interim relief sanctioned under Memo No. 142(2)-SE(B) dated 7.10.96.
- (iv) Second interim relief sanctioned under Memo No. 95-SE(B) dated 11.6.98.
- (v) An amount equivalent to 40% of the existing Pension/Family Pension.

The amount so arrived at will be regarded as consolidated pension/family pension w.e.f. 1.4.97. The upper ceiling on pension and family pension laid down in this Department Memo No. 157-Edn.(B) dated 13.6.90 has been increased from Rs. 2250/- and Rs. 600/- to 50% and 30% respectively of the highest pay as admissible to employees of the West Bengal Recognised Non-Government Aided Educational Institution (The highest pay is Rs. 13,500/-). Since the consolidated pension will be inclusive of commuted portion of pension, if any, the commuted portion will be deducted from the said amount while making monthly disbursements.

4.2 Since the consolidated pension/family pension arrived at as per paragraph 4.1 includes relief up to average index level 1510(1960=100) relief will be admissible thereon only beyond index average 1510(1960=100) in accordance with the revised scheme of relief for which orders are being issued separately. The three instalments of relief sanctioned earlier from 1.8.97, 1.12.97 and 1.4.98 in Finance Department's Memo No. 1030-F(Pen.) dated 30.9.97 Memo No. 1586-F(Pen.) dated 15.12.97 and Memo No. 470-F(Pen.) dated 20.4.98 respectively shall be adjusted against revised relief becoming due on the consolidated pension/family pension.

5. Where the consolidated pension/family pension in terms of paragraph 4.1 above works out to an amount less than Rs. 1300/- the same shall be stepped up to Rs. 1300/-. This will be regarded as pension/family pension w.e.f. 1.4.97.

6. The pensioners/family pensioners who are re-employed/employed are not getting relief on pension in terms of the existing rules/Memos. In their cases, the notional relief which would have been admissible to them but for their re-employment/employment will be taken into account for consolidation of their pension in terms of paragraph 4.1 above as if they were drawing the relief. Their pay on re-employment will be re-fixed with effect from 1.4.97 with reference to consolidated pension becoming admissible to them. Relief beyond 1.4.97 will, however, not be admissible to them during the period of re-employment/employment.

7. All Treasury Officers/Pension Disbursing Officers disbursing pension to the retired teaching and non-teaching staff of the West Bengal Recognised Non-Government Aided Educational Institutions or family pension to their beneficiary are hereby authorised to pay pension/family pension to the existing pensioners/family pensioners at the consolidated rates without any further authority from the Director of Pension, Provident Fund and Group Insurance, Government of West Bengal.

8. The Director of Pension will maintain the records and will update the Pension Payment Order Register accordingly. The fact of payment of revised/consolidated pension/family pension should be sent in Annexure-II to Director of Pension, Provident Fund and Group Insurance, West Bengal at Purta Bhavan (2nd floor), Salt Lake, Calcutta- 700 091 by the concerned Treasury Officers/Pension Disbursing Officers disbursing pension as such at revised/

consolidated rates, immediately after the payment is made. An acknowledgment shall be obtained by all T.O.s/P.D.O.s from the D.P.P.G. in this respect.

9. The Director of Pension, Provident Fund and Group Insurance will maintain the records of updating the Pension Payment Order Register. A table indicating the existing pension/family pension and consolidated pension/family pension is enclosed at Annexure-I to this Memo for ready reference. This table may be used where the pensioner is in receipt of a single pension only.

10. When a pensioner is in receipt of more than one pension, consolidation may be done separately in terms of Paragraph 4.1 and as indicated at Para 5 the overall ceiling of Rs. 1300/- may be applied to total pension from all sources taken together. A suitable entry regarding the revised/consolidated pension shall be made by the Treasury Officer/Pension Disbursing Officer in the both Treasury copy and Pensioner's copy of P.P.O.

11. The consolidated pension/family pension as worked out in accordance with the provisions of Para 4.1 above shall be treated as final "Basic Pension" with effect from 1.4.97 and shall qualify for grant of relief on pension sanctioned thereafter in respect of following categories of pensioners/family pensioners.

(i) Pensioners, who retired between the period from 1.1.86 and 31.12.95, and drew last pay on ROPA '90 scale of pay.

(ii) Family pensioners, who became eligible for family pension during the period from 1.1.86 to 31.12.95 and were sanctioned family pension @ 20% / @ 30% of the last pay drawn by the deceased employee under ROPA Rules '90.

(iii) The pensioners who retired in between 1.4.81 and 31.12.85 (both days inclusive) and pension once consolidated as per Memo No. 38-SE(B) dated 6.3.96.

(iv) Family pensioners who became eligible for family pension for death of employee in harness in between 1.4.81 and 31.12.85 or died afterwards being retired in between the said periods and family pension once consolidated as per Memo No. 38-SE(B) dated 6.3.96.

12. The arrears of pension in respect of the period from 1.4.97 to 30.6.99 on account of consolidation of pension/family pension shall be paid in six equal monthly instalments beginning monthly pension from July, 1999. The arrear payments should be completed by December, 1999. If any pensioner/family pensioner dies during this period, balance of arrear pension may be paid to his/her nominee(s) or in case if there is no nomination to his/her legal heir(s).

13. Where the pension is increased due to consolidation, such increased pension will not be considered for further commutation. There will be no increase in Death/Retiring Gratuity for such category of pensioners/family pensioners.

14. The Principal Accountant General (A&E), West Bengal, the Pay and Accounts Officer, Calcutta Pay and Accounts Office, the Director of Pension, Provident Fund and Group Insurance, West Bengal and Treasury Officer, Pension Disbursing Officer Calcutta at Purta Bhawan (2nd floor) Room No. 205, Salt Lake, Calcutta- 700 091 are being informed.

15. This order issues with concurrence of Finance Department vide their U.O. No. Group-J(Pen.)300/99 dated 24.6.99.
