## **MEMORANDUM**

Subject: Grant of relief on pension to the pensioners/ family pensioners of Recognised Non-Government Educational Institutions mentioned in Annexure-I of the Memo No. 25-SE(B) Dated 12.2.99 with effect from 1.8.97, 1.12.97, 1.4.98 and 1.11.98.

The undersigned is directed to state that consequent upon revision of pensionary benefits of the Pensioners/Family Pensioners of Recognised Non-Government Educational Institutions (Sponsored/Aided) mentioned in Annexure-I of the Memo No. 25-SE(B) dated 12.2.99, in terms of Memo No. 123-SE(B) dated 29.6.99 and Memo No. 124-SE(B) dated 29.6.99, the Governor has been pleased to decide that relief to the aforesaid pensioners/ family pensioners shall be paid according to the revised formula as follows:-

Date	Rate of relief per month
1. From 1.4.97 to 31.7.97	Nil
2. From 1.8.97 to 30.11.97	4% of Pension/Family Pension
3. From 1.12.97 to 31.3.98	8% of Pension/Family Pension
4. From 1.4.98 to 31.10.98	13% of Pension/Family Pension
5. From 1.11.98 onwards	22% of Pension/Family Pension

For the purpose of this Memo:

- (i) Pension/Family Pension in respect of employees of Recognised Non-Government Educational Institutions who retired or died prior to 1.1.96 means the consolidated pension or consolidated family pension, as the case may be, effective from 1.4.97 in terms of this Department Memo No. 124-SE(B) dated 29.6.99.
- (ii) In the case of aforesaid employee who retired or will retire from service on or after 1.1.96 or where family pension is sanctioned for the first time on or after 1.1.96, pension/family pension means the basic pension/basic family pension, as the case may be, in terms of this Department Memo No. 123-SE(B) dated 29.6.99.
- (iii) Payment of relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- (iv) Other provisions governing grant of relief to pensioners not mentioned in this memo, such as regulation of relief during employment/re-employment, regulation of relief where more than one pension is drawn etc. will remain unchanged.
- (v) A ready reckoner showing the relief payable from 1.8.97 to 30.11.97, from 1.12.97 to 31.3.98, from 1.4.98 to 31.10.98 and from 1.11.98 onwards in terms of this Memo is enclosed in Annexure-I and Annexure-II respectively.
- (vi) Payments on account of relief on pension and two instalments of interim relief made to pensioners/ family pensioners in terms of the respective orders will be adjusted against the relief payable to them under the revised pattern in terms of this order/Memo w.e.f. 1.4.97. If the entire amount cannot be adjusted from the arrears of relief payable under this Memo, the balance amount

will be adjusted against the future payment of relief in terms of this Memo.

(vii) The Treasury Officers, Pension Disbursing Officer, (PDO) will give effect to this order without the authority of the Director of Pension, Provident Fund and Group Insurance, West Bengal.

- (viii) Henceforth, relief on pension/family pension as sanctioned by Finance Department, Govt. of West Bengal to the State Govt. Pensioner/Family Pensioner from time to time will also be admissible to the Pensioner/Family Pensioner of Non-Govt. Educational Institution whose pensionary benefits has been/will be sanctioned in terms of Memo No.123-SE(B) dt. 29.6.99 or 124-SE(B) dt. 29.6.99.
- (ix) This order issues with concurrence of Finance Department vide their U.O. No. Group J (Pen.) 300/99 dt. 24.6.99.
- (x) The Principal Accountant General (A&E), West Bengal, the Pay and Accounts Officer, the Director of Pension, Provident Fund and Group Insurance, West Bengal, Pension Disbursing Officer and the Treasury Officers are being informed.
